Decisions of the Annual Meeting-2026

Meeting Date: 05 January 2026, **Time:** 6.30PM

The meeting of Unity 30 was held on **05 January 2026**. The following agenda items were discussed, and decisions were taken accordingly:

1. Confirmation of Presence

The meeting was attended by members both physically and online. All attending members were properly recorded, and the detailed attendance list (showing physical and online participation) has been attached with this meeting record for reference.

2. Last Year Finance Review (2025)

The financial position of Unity 30 for the year 2025 was discussed openly and in detail. Members reviewed:

- Total contributions received from members
- Other income and Expense
- Closing balance at the end of the year

After discussion and clarification, the financial performance for 2025 was accepted and acknowledged by all members present.

3. Increase of Monthly and Yearly Fee

The issue of revising the monthly and yearly contribution was discussed seriously by all members. Everyone agreed that an increase is necessary to support future plans and sustainability. After considering everyone’s opinion and keeping the convenience and ability of all members in mind, the meeting unanimously approved the new contribution structure:

Members discussed the savings accumulated in the IFIC Bank account during the previous year. It was agreed that this fund will be shifted to a new account to be opened with a stronger and more reliable bank.

Alongside this, members expressed strong interest in investing in land and agreed to explore suitable options. Since the existing fund is not sufficient to meet the expected land value, members unanimously agreed to contribute a one-time installment to support the investment when finalized.

6. Constitution Review & Process Decision

The constitution of Unity-30 was placed before the members for review during the meeting. As no immediate comments or objections were raised, it was decided that a scanned copy of the constitution will be shared in the official WhatsApp group.
